# LOCATION

Stansted Distribution Centre is located approximately half a mile to the east of Junction 8 of the M11 motorway at Stansted Airport. The site is accessed via the B1256 on the southern boundary of the Airport and comprises a multi-occupier business park and distribution facility.



# DESCRIPTION

The site can be described as a secure yard facility with supporting workshop and office premises. Previous uses have included car rental companies, car sales and distribution and utility vehicle depot.

On offer is a hard surfaced, secure yard area with palisade fencing. There is a workshop/storage unit/valeting bay area and single-storey modern offices with kitchenette, WC and shower facilities.
